Regular and Closed Session Meeting Minutes Tuesday, May 18, 2021

Opening:

The Chairperson of the Twentynine Palms Public Cemetery District, Mary Kay Sherry, called the regular meeting of the Twentynine Palms Public Cemetery District to order at 4:34 PM on Tuesday, May 18, 2021. Present at roll call were Trustees JoAnn Larsen, Rebecca Rinkes, Kevin Cole and District General Manager/Board Secretary, Emily Helm. Trustee Kathleen Arbaczewski was absent. All present stood and recited the pledge of allegiance.
